It influences planning applications and brings tangible local improvements. A Neighbourhood Plan carries legal weight alongside the City of York's adopted Local Plan. They will conduct a final, formal consultation where you will have another opportunity to comment, before putting the Plan to Examination. This is conducted by an independent examiner with the primary aim of ensuring that the Plan complies with all relevant legislation and guidelines. It will then come back for a Referendum in the Parish and, if approved, will become a statutory planning document.
